

Neutral Ground Members' Use of Space

Neutral Ground welcomes individual members to use the space when regular programming and staff/volunteer workload permits.

Members' Use of Space is a **free** service to our community for the artistic development of our members. This service is not a part of regular exhibition/events programming: it is not an exhibition opportunity, and no fees are paid or charged. Neutral Ground does not undertake promotion on behalf of Members' Use of Space.

Members' Use of Space includes the non-public development, workshopping, and documentation of new work or works-in-progress.

All Members' Use of Space is restricted to activities related to the mandate and objectives of Neutral Ground - available HERE.

- Members or others who wish to use the space at Neutral Ground for public performances or events should refer to the Neutral Ground Space Rental Policy on the begining of this document.
- The member may not at any time represent their use of space as an exhibition or as Neutral Ground programming.
- Members are responsible for loaned keys, and all keys shall be returned to Neutral Ground within three days. Members are responsible for the cost of lost keys, or, if necessary, the rekeying of locks to ensure the security of the space. A refundable key deposit of \$50 is required.

Guidelines for Members' Use of Space

- 1. Proposals for Members' Use of Space should be made in writing, 1 month or longer before the intended activity, to admin@neutralground.sk.ca; and include: name and contact info for the member; a brief description (250 words) of the proposed use of space including purpose, dates, duration, and physical/technical needs;
- 2. Proposals will be reviewed by staff
- 3. Members' Use of Space will be determined with consideration to the workload of staff and volunteers;
- 4. Members' Use of Space will be determined on a first-come first-served basis and with consideration of the organizational mandate;
- 5. The duration of the Members' Use of Space will be determined on a case-by case basis
- 6. Priority will be given to emerging artists and experimental practices;
- 7. All members must respect the facilities and property of Neutral Ground, and agree to the stipulations set out in the Members' Use of Space Contract;
- 8. Members may not hold public events as part of their use of space; however, the member may issue private invitations to receive feedback and input on the work in progress.
